Facility-Level Reports	
Report	Definition
Facility Reports	
Facility Personnel Report	The Facility Personnel Report allows users to run and print a report that includes facility details including location, status, shifts and services. It also provides a detailed list of all Personnel associated with the selected facility including full name, position, UPIN, email, and contact information for selected in Scope facilities.
Patient Report	
Patient Roster Report	The Patient Roster Report allows users to run and print a report that includes all patients present at the selected facility(ies) within the user scope as of a specific date or date range.
Audit reports	
Audit Forms Report	The Audit Forms report allows users to run and print a report for 2728, 2746, or both form types submitted by specified facilities within an entered date range.
Audit Additions Report	The Audit Additions report allows users to run and print a report by module to show any newly submitted records within the selected module(s) by specified facilities within an entered date range.
Audit Deletions Report	The Audit Deletions report allows users to run and print a report by module to show any deleted records within

	the selected module(s) by specified facilities within an entered date range.
Audit Updates Report	The Audit Updates report allows users to run and print a report by module to show any updated records within the selected module(s) by specified facilities within an entered date range.
Clinical Performance Measures (CPM) Reports	
ESRD CPM Hemodialysis Summary Report	The ESRD Clinical Performance Measure (CPM) Hemodialysis Summary Report allows users to run, view and print a report for a specified reporting period end month and year. The reporting period for this report is three months. The report provides percentages of patients meeting each measure and number of patients considered for each measure at the Facility, State, Network and National levels.
ESRD CPM Peritoneal Dialysis Summary Report	The ESRD Clinical Performance Measure (CPM) Peritoneal Dialysis Summary Report allows users to run, view and print a report for a specified reporting period end month and year. The reporting period for this report is six months. The report provides percentage of patients meeting each measure and number of patients considered for each measure at the Facility, State, Network and National levels.
Quality Improvement Reports	
ESRD Fistula First Summary Report	The ESRD Fistula First Summary Report allows users to run, view and print a report for a specified reporting period end month and year. The reporting period for

this report is one month. The report provides number of patients considered for the measures or percentage of patients meeting the measures at the Facility, Network and National levels.

Vascular Access Reports

Vascular Accesses in Use Report

The Vascular Accesses in Use Report displays the count and percentage of each type of vascular access used at a selected facility for a user-defined date range. The user has the ability to select various report layouts to compare data by either Month or Facility/State/Network/Nation. In addition, the report provides the user with the ability to view patient information for patients included in the facility level counts. **Note:** This report also includes a graph displaying a high-level summary of the data.

Fistula Rates Comparison Report

The Fistula Rates Comparison Report displays the count and percentage of AV Fistulas (2 needles) used at a specific facility for a user-defined date range. In addition, the report includes State, Network and National data for comparison. **Note:** This report includes a graph displaying a high-level summary of the data.

Vascular Accesses Maturing Report

The Vascular Accesses Maturing Report displays the count and percentage of AV Fistulas maturing and patients with AV grafts maturing at a specific facility for a user-defined date range. The user has the ability to select various report layouts to compare data by either Month or Facility/State/Network/Nation. In addition, the report provides the user with the ability to view patient information for patients included in the facility

	level counts.
Vascular Assessment Prior to Initiation of Dialysis Report	The Vascular Assessment Prior to Initiation of Dialysis Report displays initial patient data that was used to populate the CMS 2728 form for patients at a specific facility during a user-defined date range. The user has the ability to select various report layouts to compare data by either Month or Facility/State/Network/Nation. In addition, the report provides the user with the ability to view patient information for patients included in the facility level counts. Note: Patients with an initial 2728 form prior to March 1995 will not be included in the report.
Access Data Missing In CROWNWeb Report	The Access Data Missing in CROWNWeb Report displays a list of all patients admitted to the selected facility who do not have vascular access data entered into CROWNWeb.
Notification and Accretions Reports	
Open Accretions Report	This report will list discrepancies supplied by REMIS that will need to be researched. The report will show all open accretions for a specific facility.
Open Notifications Report	This report will list discrepancies supplied by REMIS that will need to be reconciled to the data in CROWNWeb. The report will show all open notifications for a specific facility.
Accretion Data History Report	This report will show the original data from the accretion.
Notification Data History Report	This report will show the original data from the notification.
