

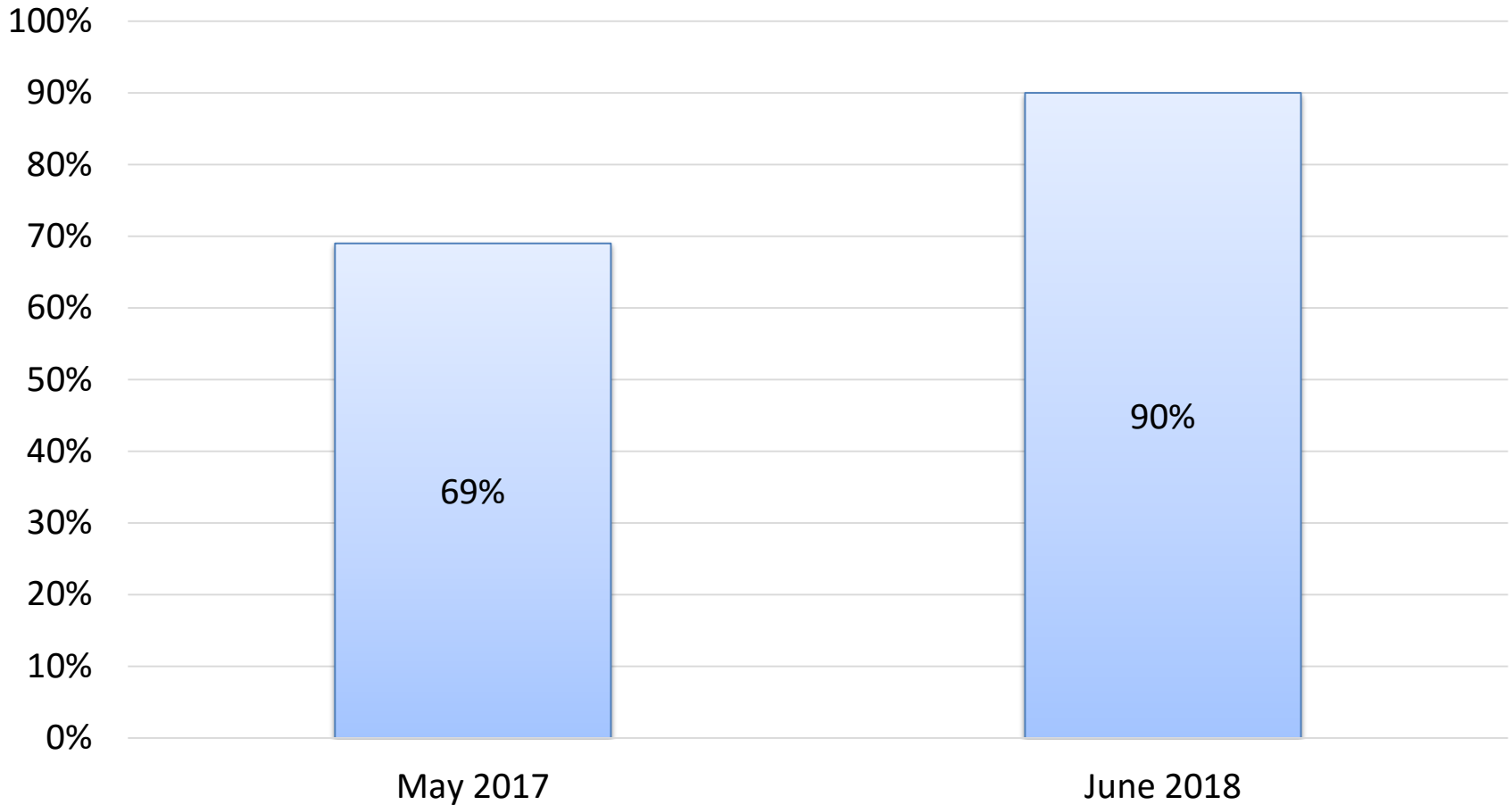

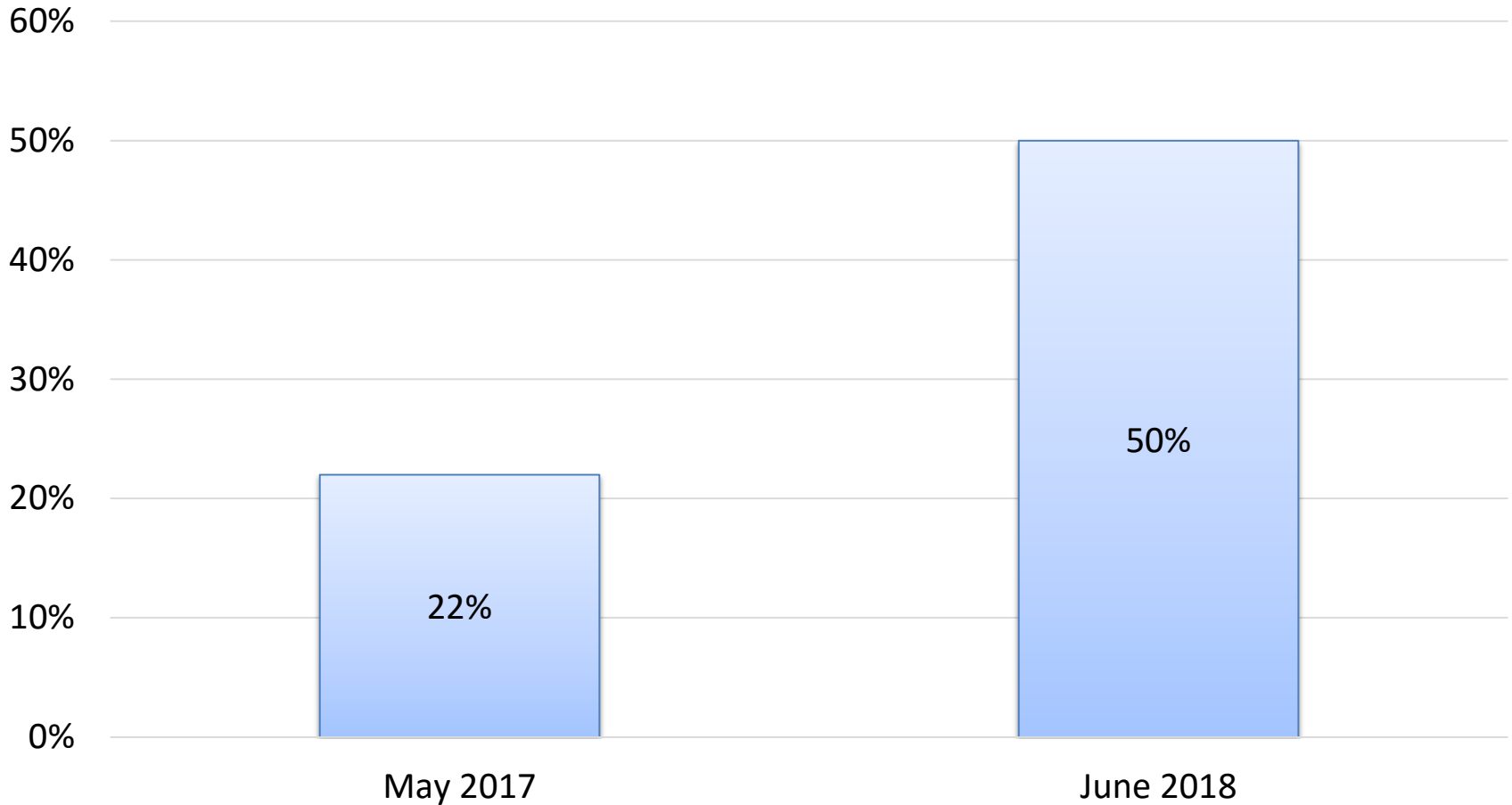
Admissions within 5 Days

Admissions w/in 5 Days of Date of First Dialysis



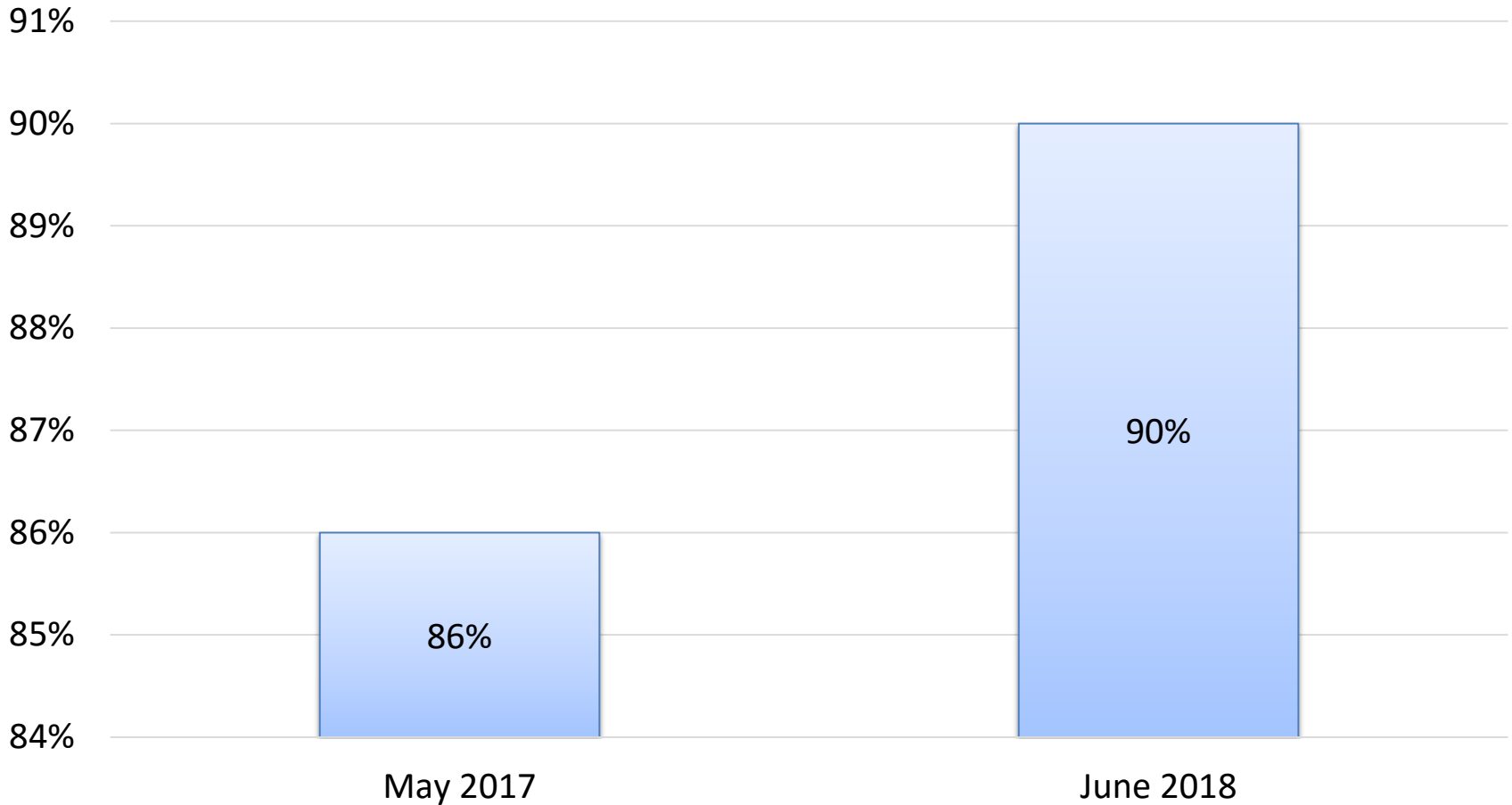
“New” Initial 2728 Forms

Initial 2728 Submitted within 10 Days



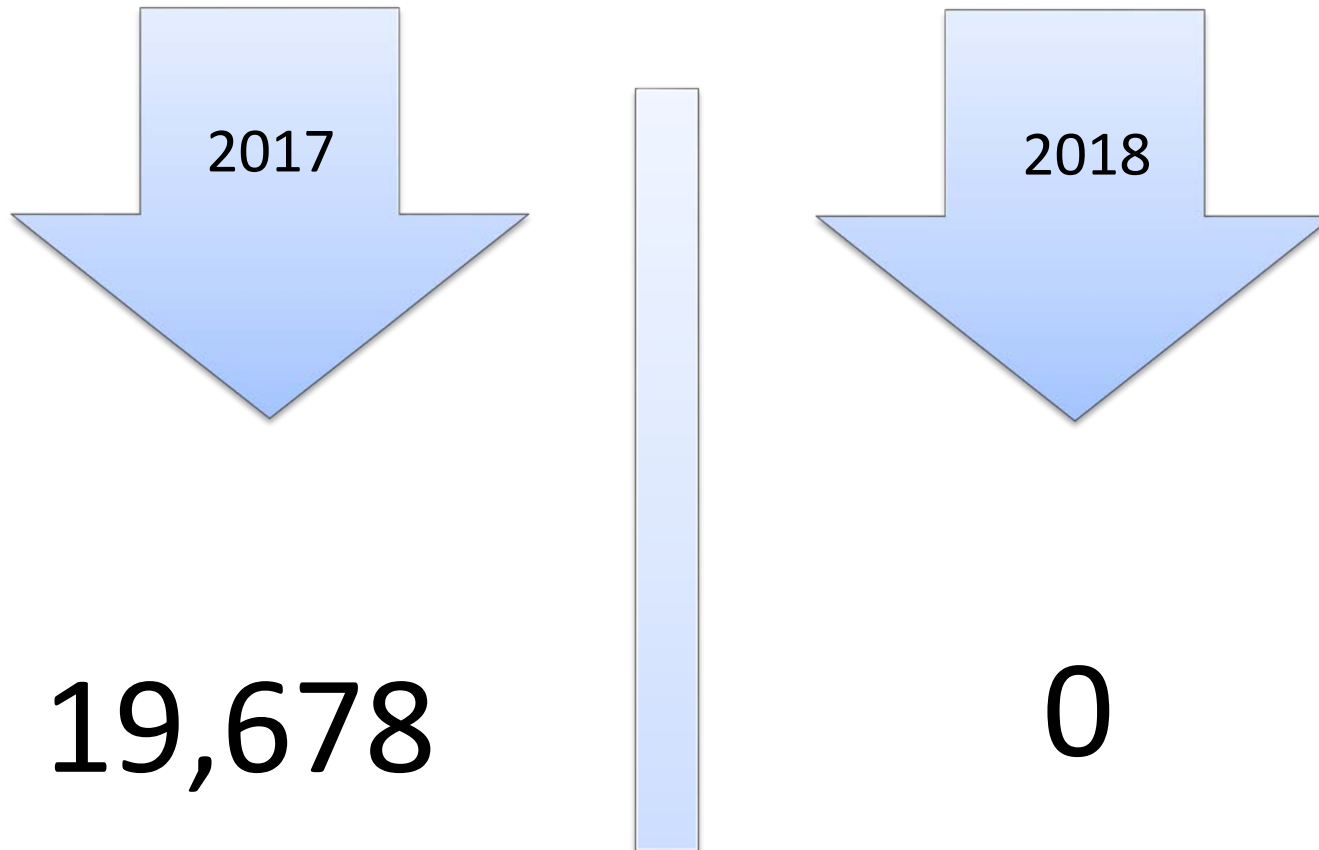
“Due” Initial 2728 Forms

Initial 2728 Submitted within 45 Days



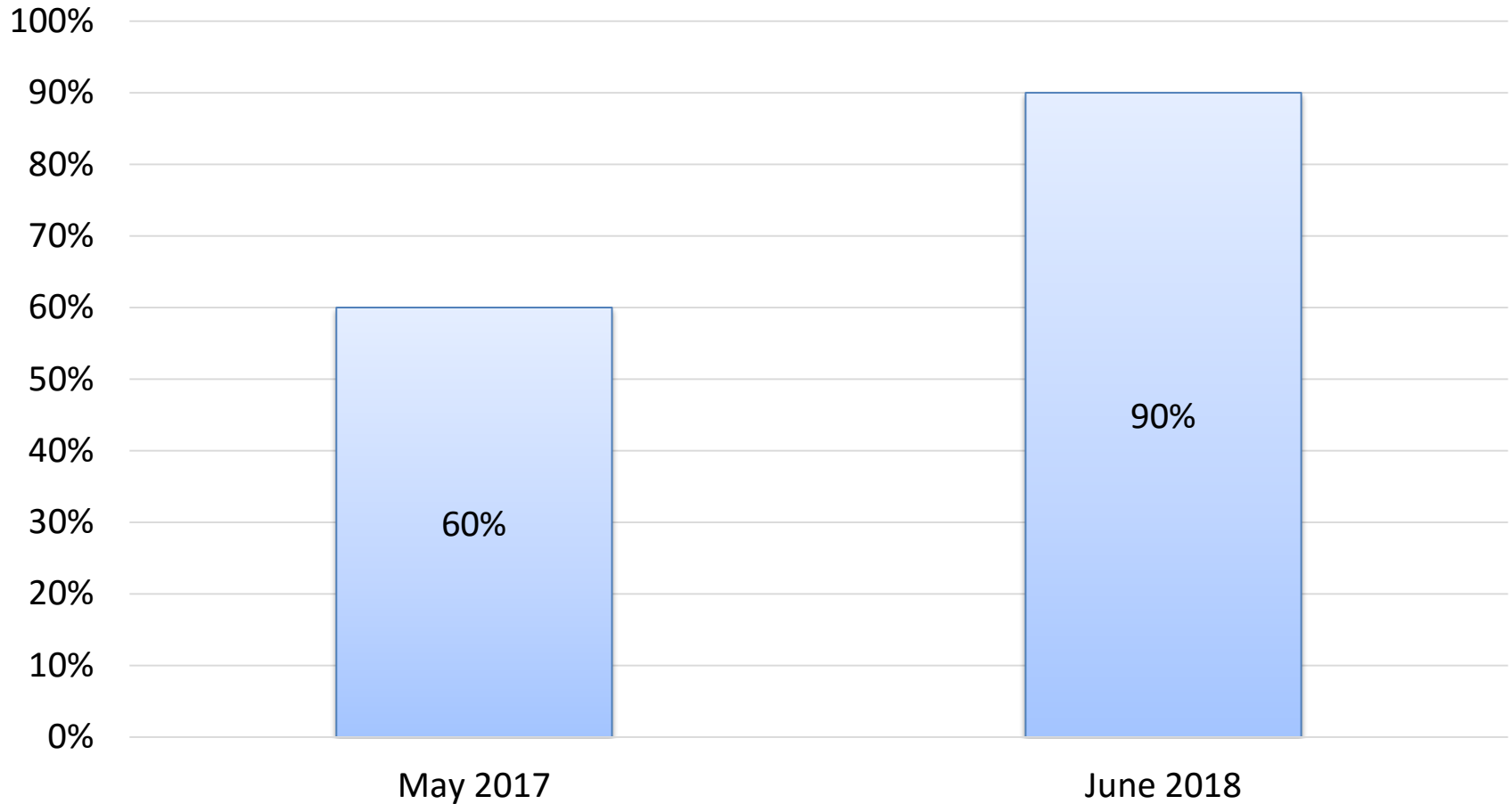
“Overdue” Initial 2728 Forms

Initial 2728 +45 Days

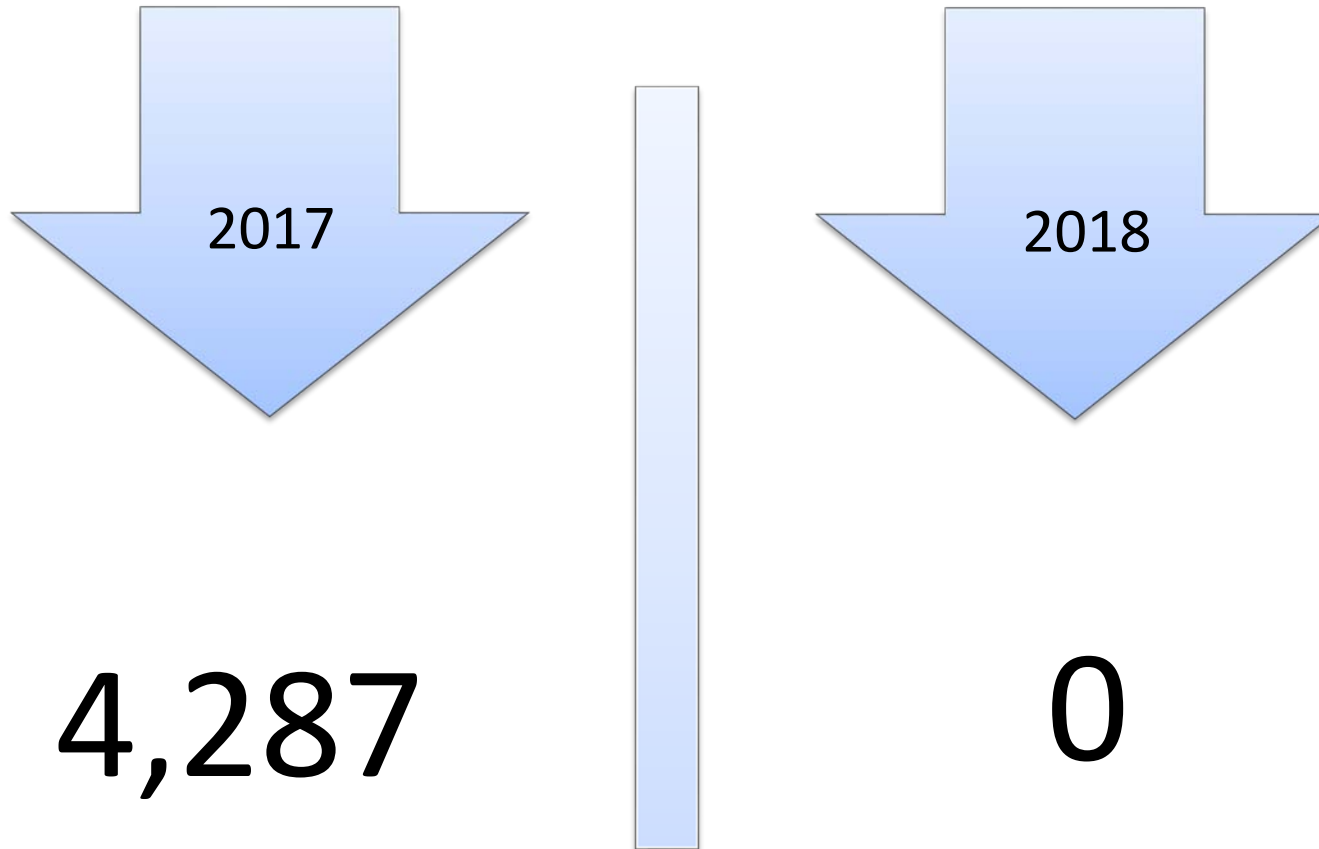

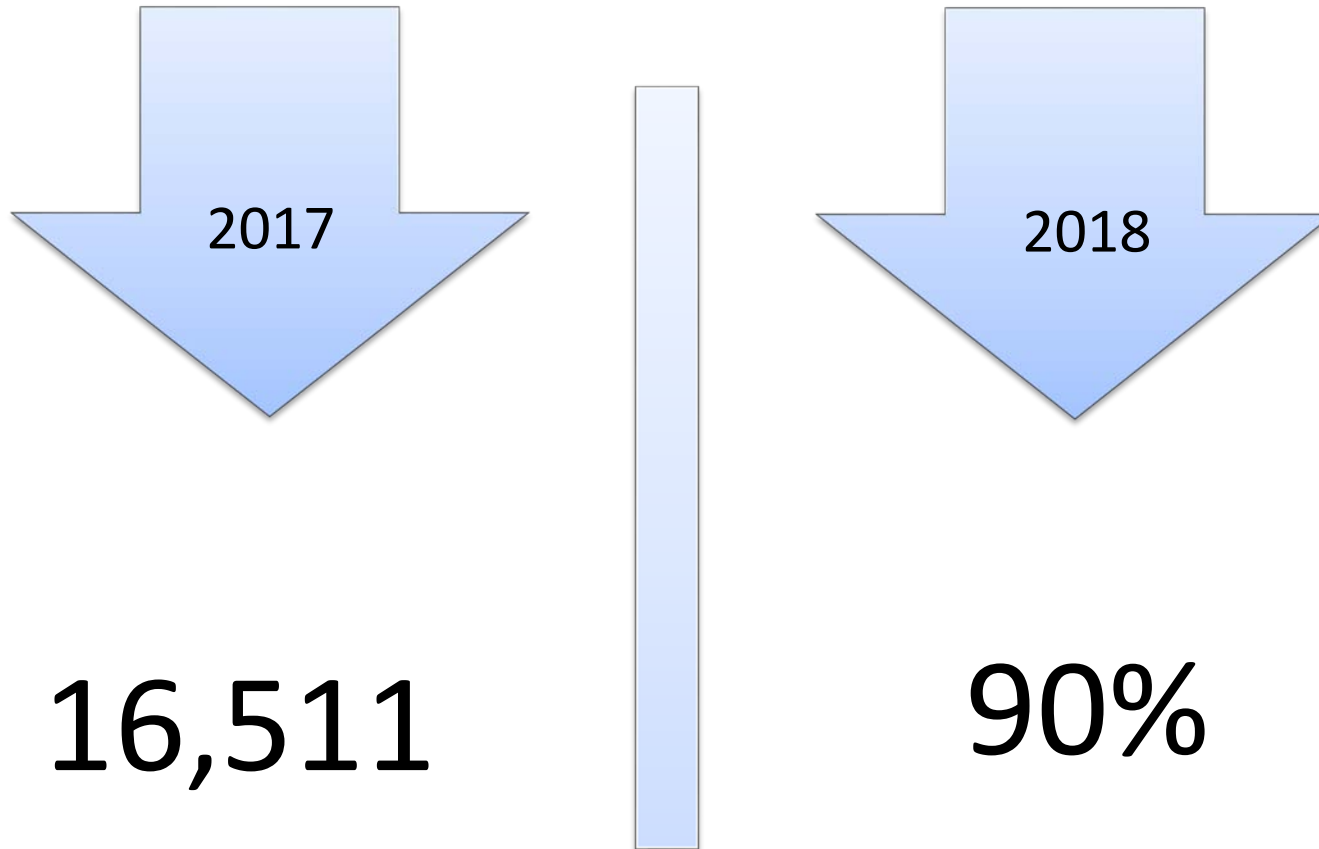

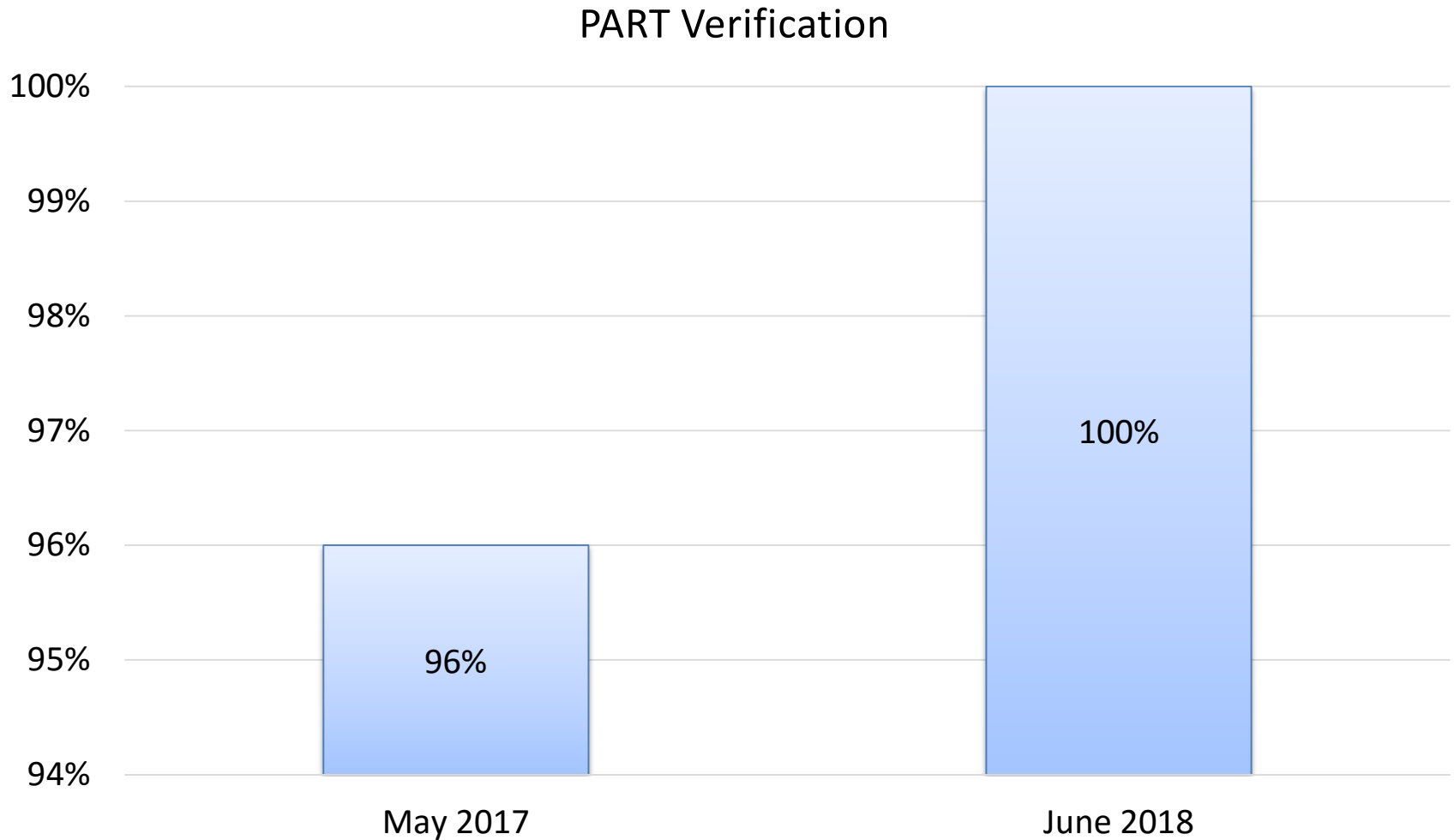
Reducing the Number of System Discharges / GAP Patients

A: The Facility Dashboard is available now. It went live on June 6th, 2017.

A: Changes made in CROWNWeb may take up to 15 minutes to sync with the Facility Dashboard.

Accessing the Dashboard

Q: I cannot gain access into the Facility Dashboard, but I am logged in?

Q: I cannot gain access into the Facility Dashboard, but I am logged in?

A: Internet Explorer 11 is the recommended internet browser. The Facility Dashboard may not populate if other browsers are used.

Transient System Discharges

Q: I have a system discharge listed, but the patient was a transient at another facility, how do I correct it?

Transient System Discharges

Q: I have a system discharge listed, but the patient was a transient at another facility, how do I correct it?

A: Please contact the visiting facility and ask them to make the correction to the patient's admission information to reflect "yes" for transient status.

If contact can not be made with the facility, then please contact your ESRD network for assistance.

Q: How long do Initial 2728 forms stay on the Facility Dashboard?

Initial 2728 Forms

Q: How long do Initial 2728 forms stay on the Facility Dashboard?

A: Initial 2728 Forms will show on the Facility Dashboard for 1 year from the patients First Date of Dialysis.

After 1 year, users may view any missing forms from the Reports Menu

Clinical Data

Q: Will past due clinical data show on the Facility Dashboard?

Clinical Data

Q: Will past due clinical data show on the Dashboard?

A: Past due clinical data will not show on the facility Dashboard.

Once a clinical month is closed, users are no longer able to enter and/or submit data for that clinical month.

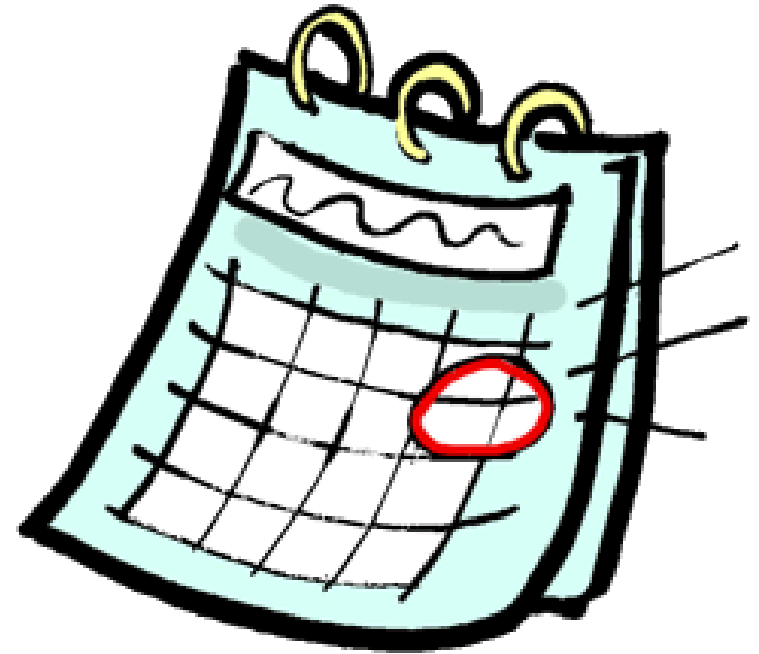
