CMS to Release CROWNWeb 4.7

In May 2015, CMS will release the latest version of its CROWNWeb data collection system—CROWNWeb 4.7. This release is primarily purposed to support CROWNWeb’s back-end and data processing capabilities. However, users will notice some enhancements when using CROWNWeb. Some of the planned updates are:

Section	Update
Facility	Facility Editors will be able to update the Additional Services (Non-Medicare) section at the facility level.
Patients	Update will help resolve the admission of duplicate patients via batch upload.
PART	Data will reflect an accurate count of days on the PART report for Transient Patients.
Reports: Duplicate Patient Report	System updated to remove non-duplicate patients.
Reports: Clinical Data and Missing Labs Report	System will not group report data from two facilities due to identical "Doing Business As" name.
Action List	Duplicate Notifications will not show in the SUI.

CMS-2744 Submission Deadlines

Have you completed your 2014 CMS-2744 annual ESRD Facility Survey? If not, what are you waiting for?! **The clock is ticking to get your 2014 CMS-2744 forms completed.** The CMS-2744 forms are completed once a year for all Medicare-certified dialysis and transplantation centers. To assist with meeting a CMS submission deadline, each ESRD Network set local due dates for facilities within their service areas. **Work to FINALIZE your CMS-2744 forms TODAY!**

True or False: CROWNWeb Clinical Data

True or False: All of the data on the *Clinical* screens in CROWNWeb automatically carry over from month-to-month; therefore you do not need to access them monthly.

False. Users who manually enter data on the *Clinical* screens must log in to CROWNWeb and report the last lab values and other clinical data obtained for patients during each Clinical Month. Additionally, it is recommended that users who do not manage the manual data entry of clinical data due to an electronic data upload (“Batch”) verify the uploaded data’s accuracy.

Some of the data on the *Hemodialysis* and *Peritoneal Dialysis* screens, and most of the data on the *Vascular Access* screen carry over from month-to-month, but they also include fields that must be updated each month for the carry over logic to continue.

Review your clinical data monthly! February 2015 clinical data due April 30, 2015.

CMS-2728 Form Validations

In January 2015, HMS—an approved CMS contractor tasked with verifying the validity and reliability of the ESRD data reported via CROWNWeb—began its 2014 CROWNWeb data validation project. As part of its efforts, HMS randomly selects a number of Medicare-certified facilities throughout the nation. It then submits a formal request for items such as patients’ clinical data, and completed CMS forms. **Please note that as part of its CMS-2728 form validation process that HMS will require medical records to support changes.**

Welcome to MyCROWNWeb.org

Since the initial rollout of CROWNWeb, CMS has utilized <http://www.ProjectCROWNWeb.org> as the online communication and training resource for all CROWNWeb users. The Web address was ideal during CROWNWeb’s pilot phases. However, with the system being used by more than 6,000 Medicare-certified facilities, it is no longer in a “project” phase. With this in mind, **in March 2015, CMS changed the CROWNWeb communication and training Web address to <http://www.MyCROWNWeb.org>.** Users can access the same materials that were available via <http://www.ProjectCROWNWeb.org> at <http://www.MyCROWNWeb.org>. Users are currently being redirected to the correct website, but they are encouraged to change any bookmarks to the new Web address.
