## **MyCROWNWeb Website Updates**

CMS and OCT strive to make sure the entire ESRD community has up to date information on CROWNWeb and the ESRD QIP system. There is a consistent rotation of new information being added to the <a href="https://www.mycrownweb.org">www.mycrownweb.org</a> website. The most recent updates have been the renaming of the tabs at the top of the home page last week. This update was done to improve navigation for website users. Ongoing updates have been the completion of the <a href="https://example.com/HELP files">HELP files</a> as well as the <a href="https://example.com/tutorials">tutorials</a> to reflect CROWNWeb 5.0. At this time twelve tutorials (About CROWNWeb, Admit A New Patient, Discharging A Patient, Admit and Discharge Transient Patients, Edit Patient Attributes, Manage Clinical Data, and View and Verify PART Data) have been updated.

#### **Transient Patients in CROWNWeb**

A transient patient is one who is expected to be managed by the dialysis facility for 30 days or less or 13 treatments or less. In CROWNWeb, a patient can only be assigned to one primary facility at a time. An admission to a secondary facility for a short duration requires the user to indicate the patient is a transient. Facilities are required to admit all transient patients to their facility in order to maintain a proper census count of their patients. To admit a transient
